



Rules

1. Safety

- 1.1 Hard hats must be worn at all times while mounted.
- 1.2 Absolutely no riding without adult supervision. (Adult: 18 & up)
- 1.3 No riding alone, no exceptions.
- 1.4 No jumping, unless in a lesson or with a trainer's permission
- 1.5 No minor shall be left unattended. Hunter's Edge Stables, Inc. is not responsible for any minor left unattended.
- 1.6 No mounting horses or riding in the barn.

2. Citizenship

- 2.1 Everyone is responsible for cleaning up after your horse, including the wash racks and grooming stalls.
- 2.2 Riders are to treat all trainers, adults, other riders and all horses with respect at all times.
- 2.3 Riders are to respect the personal property of others.
- 2.4 Lessons take priority in the ring. If there is a lesson taking place, you must politely ask the trainer teaching the lesson for permission to ride in the ring along with the lesson.
- 2.5 Unless it is an emergency, trainers are not to be interrupted while conducting lessons.
- 2.6 Each rider is to put away all tack and belongings. Hunter's Edge Stables, Inc. is not responsible for personal items left on premises.
- 2.7 All riders are to arrive in enough time to be tacked and ready to enter ring at the start of lesson time. All riders should allow enough time after the lesson to properly cool out and clean up their horse and to put away all tack and supplies.
- 2.8 **Lessons are scheduled on the hour and are not required to last an hour. It is the trainers job to decide how much work is necessary for the horse rider combination.**

3. Health

- 3.1 No feeding grain, hay or TREATS to any horse other than your own without owner's or trainer's permission.
- 3.2 If there is any change in feed, supplements, medicine or turnout instructions for your horse, notify management of both Hunter's Edge Stables, Inc. and boarding barn in writing.

4. Financial

- 4.1 **Payment is expected at time of service or may be prepaid monthly.**
- 4.2 Late fees for invoices will incur at the rate of \$25.00 per week. Any account more than 30 days past due will not be allowed to schedule any more lessons until account is cleared.
- 4.3 Returned checks will be charged a \$35.00 insufficient funds fee for processing in addition to all expenses incurred to collect debt.
- 4.4 Any account 60 days past due or later are subject to collection actions and you will be responsible for all costs of collection and reasonable attorney's fees.
- 4.5 There is a 24 hour cancellation policy for lessons. Any lesson cancelled within 24 hours of appointment will still be charged. No shows will be charged.
- 4.6 **Lesson payment is due at the time of service. Payment for lesson package must be complete before the first lesson of the new package starts.**
- 4.7 The last person to leave for the night please turn off lights, shut doors (Cold Weather), and lock the gate at the front driveway gate

Rules are in place for everyone's safety. There are **no** exceptions. Hunters Edge Stables, Inc. expects its students to follow these same rules whether at training facility or on show grounds. Hunters Edge Stables, Inc. students are expected to display high standards of good horsemanship and conduct at all times. If anyone breaks any of the above rules. that person may be asked to leave the program and no longer be allowed to represent Hunters Edge Stables, Inc.
